



Call for Nominations for the 2017 Katy Area Chamber of Commerce Board of Directors

Pursuant to Article IV, Section 3 of the Katy Area Chamber of Commerce Bylaws, the Nominating Committee is considering applications for the Board of Directors. **Qualified candidates must submit a fully completed application by November 4, 2016 to the Katy Area Chamber of Commerce for consideration.**

The term of office is for 3 years unless the candidate fills an unexpired term. The Board of Directors currently consists of 21 members. The Board of Directors meets once a month for no more than 2 hours. All members of the Board of Directors must attend monthly meetings, Chamber functions and volunteer their time and energy for various Chamber projects. The Board of Directors is expected to serve as positive leaders of the Chamber and to demonstrate their commitment to the Chamber.

The Board member must be a member in good standing in the Katy Area Chamber of Commerce. Additionally, no more than one representative from any member organization may serve on the Board simultaneously.

We encourage our members to apply. Applicants are selected based upon service in the Chamber as well as background and experience. Unfortunately, we cannot accept every applicant, but we encourage you to continue to apply if you are interested.
